MEETING WAS CALLED TO ORDER at 7:30 p.m. by Mayor Rogers in the Council Chambers at the Civic Center, 5000 Clark Avenue, Lakewood, California.

ANNUAL REORGANIZATION OF CITY COUNCIL

Steve Skolnik, for the City Attorney, explained that due to the unusual circumstance of the timing of the election in March and the vacancy of the Mayor's office in April, which created the need to fill the seat, City Council reorganization was being considered again at this time when it would normally occur.

Mayor Rogers expressed gratitude to the residents of Lakewood and nearby communities who came to the Veterans Memorial Plaza the previous day to raise the American and POW/MIA flags for the first time since an arsonist had damaged them on the night of July 4th. Council Member Wood stated that the Lakewood High School Alumni Association picnic would be held on July 14th at Del Valle Park.

The Mayor welcomed Hector De La Torre, Executive Director of the Gateway Cities Council of Governments, who provided an update on their activities.

ORDINANCE NO. 2024-4; AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAKEWOOD AMENDING THE LAKEWOOD MUNICIPAL CODE TO AUTHORIZE BACKYARD BEEKEEPING FOR HONEYBEES ON NO MORE THAN TEN LOTS AT ANYTIME CITYWIDE WITHIN BOTH THE R-1 (SINGLE FAMILY RESIDENTIAL) AND R-A (RESIDENTIAL AGRICULTURE) ZONING DISTRICTS SUBJECT TO DEVELOPMENT STANDARDS
