Regular Meeting held September 24, 2024

MEETING WAS CALLED TO ORDER at 7:51 p.m. by Mayor Rogers in the Council Chambers at the Civic Center, 5000 Clark Avenue, Lakewood, California.

Mayor Rogers announced that Council Member Steve Croft would be attending the meeting via teleconference, pursuant to the provisions of California Government Code Section 54953(f)(2)(A)(i), for "just cause," as set forth in Section 54953(j)(2). 2.1 • RESOLUTION NO. 2024-58; EXPRESSING SUPPORT FOR THE HOMELESSNESS, DRUG ADDICTION AND THEFT REDUCTION ACT (PROPOSITION 36)

Joshua Yordt, Director of Public Safety, displayed slides and made a presentation based on the report in the agenda. He reported that the "Californians for Safer Communities" Coalition's Proposition 36, also known as the "Homelessness, Drug Addiction and Theft Reduction Act" had qualified for the November 2024 statewide ballot. He stated that the measure would increase penalties for trafficking of hard drugs including fentanyl, increase penalties for those who repeatedly engage in theft, add new laws to address the problem of smash and grabs and organized retail theft, and provide diversion programs for repeat offenders. Mr. Yordt added that both the City's Public Safety Committee and the Intergovernmental Relations Committee recommended support for the proposed resolution to support the Homelessness, Drug Addiction and Theft Reduction Act (Proposition 36).

3.1 • PROPOSED PUBLIC SAFETY JOINT POWERS AUTHORITY

The Public Safety Director displayed slides and made a presentation based on the report in the agenda. He provided a brief overview on the collaborative efforts by the cities of Bellflower, Lakewood and Paramount to develop a concept of expanding upon and increasing shared public safety resources with the formation of a Public Safety Joint Powers Authority. It was staff's recommendation that the City Council approve an agreement to form a public safety Joint Powers Authority with the cities of Bellflower and Paramount, and authorize the Mayor to sign the agreement in a form as approved by the City Attorney.

Staff responded to questions and comments from Council Members regarding the draft agreement, contract termination provisions and board appointments and structure of the joint powers authority.
