Lakewood City Council

Regular Meeting held October 8, 2024

MEETING WAS CALLED TO ORDER at 7:30 p.m. by Mayor Rogers in the Council Chambers at the Civic Center, 5000 Clark Avenue, Lakewood, California.

INVOCATION was offered by Bishop Dave Montgomery, Church of Jesus Christ of Latter Day Saints

PLEDGE OF ALLEGIANCE was led by Scout Troop 65

Mayor Rogers stated that pursuant to Government Code §54953 and as noticed on the agenda, the meeting would include a teleconference location where Council Member Steve Croft was attending the Risk Management Forum of the California Joint Powers Insurance Authority, where he represented Lakewood and served on the Executive Board. Mayor Rogers determined from Council Member Croft that he had a copy of the agenda, that the agenda had been posted at the location, and the location provided an opportunity for members of the public to participate. Mayor Rogers noted that all votes taken during the teleconference would be taken by roll call vote.

ANNOUNCEMENTS AND PRESENTATIONS:

Mayor Rogers announced that the meeting would be adjourned in memory of Tami Hayworth, who was killed when struck by a car involved in a roadway accident, and the victims of the October 7, 2023, Hamas-led attack of Israeli civilians, including 40 Americans. He commented on the Jewish commemorations of Rosh Hashanah and Yom Kippur. He stated that October was Breast Cancer Awareness Month and the City was joining the call to wear pink in support.

Council Member Arellano spoke of his support on the observance of Breast Cancer Awareness Month since he lost his mother to the disease.

Council Member Wood reported on his attendance at recent events including the Public Safety Expo and the Friends of the Lakewood Libraries where he met with Anthony Iacoboni, the son of Angelo Iacoboni, who was the first Mayor of Lakewood.

Council Member Croft congratulated Mayor Rogers on his recent appointment as Chief of Police at Rio Hondo College.

Mayor Rogers stated that he had attended the farewell event for Assembly Member Anthony Rendon and wished him well.

2.1 • RESOLUTION NO. 2024-61; APPROVING THE INFRASTRUCTURE FINANCING PLAN FOR THE LAKEWOOD ENHANCED INFRASTRUCTURE FINANCING DISTRICT AND THE ALLOCATION OF PROPERTY TAX INCREMENT

Thaddeus McCormack, City Manager, introduced Joe Dieguez, Senior Vice President, Kosmont Companies, who displayed slides and explained the Infrastructure Financing Plan for the Lakewood Enhanced Infrastructure Financing District. He reviewed tax increment financing; contents of the Plan; proposed map; future development assumptions; potential investments for funding; financing section draft terms; regional and communitywide significance; ability to attract other funding; and targeted formation schedule. Mr. Dieguez stated that the City Council and County Board of Supervisors must independently approve the Infrastructure Financing Plan before the Public Financing Authority formed the Enhanced Infrastructure Financing District. It was recommended that the City Council adopt the proposed resolution approving the Infrastructure Financing Plan for Lakewood Enhanced Infrastructure Financing District and allocation of property tax increment within the Lakewood Enhanced Infrastructure Financing District.

Staff responded to questions and comments from Council Members regarding tax increment allocation and the timeline for the process.
