Regular Meeting held March 14, 2023

MEETING WAS CALLED TO ORDER at 7:30 p.m. by Mayor Croft in the Council Chambers at the Civic Center, 5000 Clark Avenue, Lakewood, California.

ANNOUNCEMENTS AND PRESENTATIONS:

Mayor Croft announced that the meeting would be adjourned in memory of former Lakewood resident and four-time Olympic gold medalist diver Patricia McCormick.

The Mayor commended staff for their hard work and success of the recent Earth Walk event. He also encouraged residents to submit their nominations for the Lakewood Beautiful program which was accepting nominations through March 29.

Mayor Croft also commented on the recent opening day event for Lakewood Little League which was attended by two team members from the 1960 East Lakewood All-Stars team that won third place in Little League World Series. It was a great event and the little leaguers enjoyed kicking off their season in such a memorable way.

The Mayor announced the formation of an Ad Hoc Committee on Accessory Dwelling Units (ADUs) which had been requested by staff to provide guidance on the amendment of the City's ordinance regarding ADUs to bring it into compliance with State laws and regulations that had changed over the past year. He appointed Vice Mayor Pe and himself to the committee.

Council Member Chase acknowledged that it was Women's History Month and a time to celebrate the important role that women have in our society. She recognized the five female council members who served before her as well as the current female commissioners, committee members, school board members and City of Lakewood directors.

Council Member Rogers noted that over 200 new businesses opened in Lakewood in 2022 and he encouraged residents support them.

Mayor Croft welcomed Mayra Garza, Bellflower Unified School District (BUSD) Board President, who introduced new BUSD Board Members Amie Stewart and Brad Crihfield. 3.1 • 2023 ILLEGAL FIREWORKS PUBLIC EDUCATION & ENFORCEMENT PLAN

Joshua Yordt, Director of Public Safety, displayed slides and made a presentation based on the report in the agenda. He summarized the comprehensive plan to suppress illegal fireworks in the City, which included public education with an emphasis on reporting illegal fireworks; proactive patrols in areas with historical illegal fireworks use; and enforcement operations on July 3 and 4. He stated it was recommended that the City Council receive and file the report.

Staff responded to comments and questions from Council Members.

3.2 • 2022 GENERAL PLAN ANNUAL PROGRESS REPORT

Abel Avalos, Director of Community Development, displayed slides and made a presentation based on the report in the agenda pertaining to the General Plan Annual Progress Report. He noted that a significant change during 2022 was that Lakewood's Housing Element was adopted and certified as being in full compliance with State Housing Element Law. He concluded by stating it was recommended that the City Council receive and file the 2022 General Plan Annual Progress Report and direct staff to submit the same to the Department of Housing and Community Development and to the Governor's Office of Planning and Research.
