## 1.1 • APPEAL OF CONDITIONAL USE PERMIT NO. 279, AMENDMENT NO. 3, 4311 SOUTH STREET

Steve Skolnik, for the City Attorney, stated that this was the time scheduled for the City Council to hear an appeal of the decision of the Planning and Environment Commission regarding Conditional Use Permit No. 279, Amendment No. 3. He briefly reviewed the Council's options for the hearing, as governed by the Lakewood Municipal Code, which included making a decision based on the record of the Planning and Environment Commission hearing and taking no new testimony or evidence; or the Council could set a de novo, or new, hearing and set a date for that hearing, the appropriate course of action should the Council desire to conduct a full hearing. He explained that the appellant and counsel for the applicant submitted a joint letter requesting the City Council open the public hearing and immediately adopt a motion to hear the appeal and set a hearing de novo on August 8, 2023. It was staff's recommendation that the City Council set a public hearing de novo for CUP 279, A-3, on August 8, 2023, at 6:00 p.m.

Jeff Wysard, owner of a neighboring property adjacent to the site, stated his willingness to defer his comments until the August 8th hearing.

## 3.1 • AWARD OF BID FOR PUBLIC WORKS PROJECT NO. 2023-7; WATERMAIN REPLACEMENT FY24

Derek Nguyen, Director of Water Resources, displayed slides and made a presentation based on the report in the agenda regarding the Watermain Replacement project, which included the installation of new water mains, valves, fire hydrants, service lines, and would improve water quality, serviceability, fire protection and water supply reliability to the area. He concluded by stating that staff recommended that the City Council award a contract for Watermain Replacement FY24 - PW Project 23-7 in the amount of \$3,799,175 to All Cities Engineering of Jurupa Valley and authorize the Mayor to sign the contract in a form approved by the City Attorney; authorize staff to approve a cumulative total of change orders as needed not to exceed \$350,000; adopt the plans, specifications and working details for the project and appropriate a total of \$4,350,000 from the Water Enterprise Fund and authorize staff to approve services for inspection, soil compaction and miscellaneous tests as necessary for the corresponding project.

## 3.2 • PROFESSIONAL SERVICES AGREEMENT WITH WOOD RODGERS, INC. FOR WELL 22 COMPREHENSIVE SITE ASSESSMENT AND HYDROGEOLOGIC SERVICES FOR WELL DRILLING AND CONSTRUCTION SUPPORT

The Water Resources Director displayed slides and made a presentation based on the report in the agenda pertaining to a Comprehensive Site Assessment for the existing Plant 22 site to determine the best and highest use for the City's water operations.

## 3.2 • WELL 22 COMPREHENSIVE SITE ASSESSMENT AND HYDROGEOLOGIC SERVICES FOR WELL DRILLING AND CONSTRUCTION SUPPORT - Continued

Staff recommended that the City Council approve a Professional Services Agreement with Wood Rodgers, Inc. for Well 22 Comprehensive Site Assessment and Hydrogeologic Services for Well Drilling and Construction Support in a not-to-exceed amount of \$410,395 including a 10% contingency of \$41,039.50 and authorize the Mayor to sign the corresponding agreement in a form approved by the City Attorney; and appropriate a total of \$451,434.50 from the Water Enterprise Fund FY 2024 Budget for the corresponding project.

# 3.3 • AGREEMENT WITH CARE SOLACE, INC., TO PROVIDE A WEB-BASED NAVIGATION SYSTEM TO ASSIST CITY RESIDENTS IN LOCATING AND CONNECTING WITH MENTAL HEALTH TREATMENT PROVIDERS AND SERVICES

City Manager Thaddeus McCormack displayed slides and made a presentation based on the report in the agenda. He explained that City staff had been approached by Care Solace to discuss a proposal to initiate a pilot program to provide mental health care coordinator services to all City of Lakewood residents. He noted that Care Solace was not a direct provider of services, but instead helped people navigate through the process involved with both public and private mental health providers. Mr. McCormack stated that it was staff's recommendation that the City Council approve the contract with Care Solace and appropriate \$33,750 of American Rescue Plan Act funding.
