

Minutes Lakewood City Council Regular Meeting held July 11, 2023

MEETING WAS CALLED TO ORDER at 7:46 p.m. by Mayor Croft in the Council Chambers at the Civic Center, 5000 Clark Avenue, Lakewood, California.
