Regular Meeting held August 8, 2023

MEETING WAS CALLED TO ORDER at 7:31 p.m. by Mayor Pe in the Council Chambers at the Civic Center, 5000 Clark Avenue, Lakewood, California.

ANNOUNCEMENTS AND PRESENTATIONS:

Mayor Pe stated that pursuant to Government Code Section 54953(b), Council Member Chase would participate in the meeting via teleconference.

The Mayor announced that the meeting would be adjourned in memory of Matias Alvarez, father-in-law of Community Services Manager Chuck Martucci.

Mayor Pe welcomed Congresswoman Nanette Barragan, one of Lakewood's new Members of the U.S. House of Representatives. Congresswoman Barragan shared that she was the Representative for California's 44th Congressional District, which included nearly half of Lakewood. She added that she was working to secure funding for improvements to Weingart Senior Center, address homelessness, and expand mental health services. Congresswoman Barragan shared her appreciation for the receptiveness of the Council and their partnership. The Council Members thanked Congresswoman Barragan for her service to Lakewood residents and Mayor Pe presented her with a City pin as a symbol of the City's friendship.

The Mayor introduced Dr. Gina Zietlow, Superintendent for ABC Unified School District, who gave an update on the district which included that growth and strength was apparent in students after the pandemic; a virtual academy for students was created at the request of families; providing support and resources for learning to students was a priority; and various safety measures were taken to create safe spaces for learning. Mayor Pe welcomed the new Superintendent to the community and presented her with a City pin.

Mayor Pe announced that Captain Dan Holguin, commander of the Lakewood Sheriff's Station, would provide the Quarterly Public Safety Report. Captain Holguin summarized the results of the Fourth of July illegal fireworks suppression efforts, which included responding to

110 calls for illegal fireworks and issuing 50 citations. He noted that there was an overall decrease in crime throughout the City and at Lakewood Mall when compared to the same time last year. He added that resident support was evident when deputies attended community events and resulted in high morale at Lakewood Station. He concluded by thanking the City Council, City Manager and the Public Safety team for their continued leadership, partnership and support.

1.2 • INTRODUCTION OF ORDINANCE NO. 2023-6; RELATING TO LAKEWOOD MUNICIPAL CODE (LMC) UPDATES

City Manager Thaddeus McCormack noted that there was a study session meeting earlier in the evening on the proposed ordinance, which resulted in revised parking language and direction for staff to study domestic bee keeping.

Assistant Director of Community Development Patrick McGuckian displayed slides and made a presentation based on the report in the agenda pertaining to updating various sections of the Lakewood Municipal Code. He stated that it was the recommendation of the Planning and Environment Commission that the City Council hold a public hearing; introduce the proposed ordinance; approve the related California Environmental Quality Act (CEQA) exemption; and instruct the Community Development Director to conduct a study regarding backyard beekeeping of honeybees as a potential allowed land use.

The City Manager read the revised wording for section 9321 in the proposed ordinance that was a result of the study session and noted that staff would refine the language.

Staff responded to questions and comments from Council Members.

Mayor Pe opened the public hearing at 8:42 p.m. and called for anyone in the audience wishing to address the City Council on this matter.

1.3 • COLLECTION OF DELINQUENT ADMINISTRATIVE CITATION FINES

The Assistant Director of Community Development displayed slides and made a presentation based on the report in the agenda pertaining to unpaid administrative citations fines for code violations, which may be collected by placement of a lien on the property on which the violations occurred, provided the fine owed by the cited party had been delinquent for ninety days or more. He concluded by stating it was staff's recommendation that the City Council conduct a lien hearing and consider all competent evidence presented related to any outstanding delinquent fine amounts, late fees and related costs from fiscal year 2022-2023; adopt the proposed resolution finding that the final list of delinquent 2023 fines and related costs are due to the City as cost of nuisance abatement; order the outstanding delinquent fines to be paid; and direct staff to forward a final list of the unpaid fines to the County Tax Assessor for collection as a lien on the related property, as part of the annual property tax assessment.
