### Valid Government Issued ID Required

Please upload a photo(s) of a valid government issued ID. Please note that the following criteria must be met:

ID must display your current City of Lakewood residential address  
ID must be valid

### Current Lakewood Utility Bill Required

Current utility bill (water, electricity, gas, phone) registered in your name to your City of Lakewood residential address, matching the Lakewood address on your valid government issued ID. Your utility bill must be dated within 60 days of submitting your application

### Sales Receipt Required

To be eligible for the \$75.00 rebate, each security camera device must have a total sale price, before taxes and installation, of \$100.00 or greater.

To be eligible for the \$150.00 rebate, the total sale price, before taxes and installation, must be \$200.00 or greater, and there must be a minimum of two individual cameras.
